**Step 3:** Enter the descriptions and maximum bid amounts of the item(s) you are interested in bidding on page 3 of 3.

**Step 4:** Print, sign and date page 3 of 3 and send all three pages back to Lauro Auctioneers by mail, fax or email.

**Step 5:** Make deposit(s) either by Cash, Cashier's Check made payable to Lauro Inc, Wire Transfer or Direct Deposit (contact us for instructions) for each item you are interested in bidding on.
